## 4 ANALYSIS & CONCLUSION

### 4.1 Observations:

From the above comparison the following points may be summed up:

- All the bidders have submitted the necessary Tender Fee amount of ₹ 2000.00 as per requirement of the Tender.
- All the bidders have valid credentials of single value 'Building or Bridge Works' of similar types except **M/s Friends Engineers Co-op Society Ltd** (Bidder- 3) and **M/s SK Jiyaul** (Bidder- 4).
- For basic qualification criteria, it is required a minimum single value Building or Bridge Works of ₹ 14.55 Lacs in the last 3 years. All the bidders have executed the job of said value, but the documents furnished by **M/s Friends Engineers Co-op Society Ltd** (Bidder- 3) and **M/s SK Jiyaul** (Bidder- 4) are not the work of a Single Building or Bridge works. So their bidding have not been considered for this job.
- All the bidders have valid Income Tax PAN registration and IT return.
- All the bidders have submitted valid Professional Tax Challan Receipt and VAT Registration & return.
- Except **M/s Bharat Construction** (Bidder- 6), no other bidder have furnished any Service Tax document with the Part-I bid.

### 4.2 Recommendation:

Since the **M/s MR Enterprise** (Bidder- 1), **M/s Dhananjay Ganrai** (Bidder- 2), **M/s SK Amir Ali** (Bidder- 5) and **M/s Bharat Construction** (Bidder- 6) are considered to have suitable experiences in undertaking single value 'Building or Bridge Works' of similar types in public and statutory bodies, the only criteria left for selecting is the Financial Aspect of their bids.

It is recommended that Part-II: Financial Bid documents of above bidders can be considered for the tender process.
